PRAYER: This petition is filed under Article 226 of the Constitution of India for issuance of Writ of Habeas Corpus to call for the records leading to the detention of the petitioner's son H.Devaraj, @ Deva, son of Haribabu, aged 26 years is presently lodged in Central Prison, Puzhal and has been detained under Act 14/82 as a Goonda vide detention order dated 28.11.2019 on the file of the 2nd respondent herein, made in No. 819/BCDFGISSSV/2019 quash the same and consequently direct the respondent herein to produce the body and person of the said detenu before this Court and therefore set him at liberty from the Central Prison, Puzhal.
