Dr.C.Ravichandran, learned Standing Counsel appearing for respondents 1 to 5 submitted that the Corporation has initiated action against the sixth respondent by issuing Lock & Seal and Demolition notice dated 06.01.2020 and that they would proceed further in accordance with law.
