ORDER

This writ petition has been filed by the petitioner seeking for a direction to the first respondent to issue appropriate orders for commencement of payment of pension to the writ petitioner under Contributory Pension Scheme No.7059186/EDN, based on the petitioner's representation dated 20.01.2015.

According to the learned Additional Government Pleader appearing for the respondents 1, 4 and 5 submitted that the petitioner sought for prayer in the writ petition with respect to Contributory Pension Scheme amount of Rs.4,59,184/- together with interest has been settled to the writ petitioner by the respondents, as per letter in Na.Ka.No.8624/A3/2015, dated 22.11.2017 issued by the Chief Educational Officer, Coimbatore. 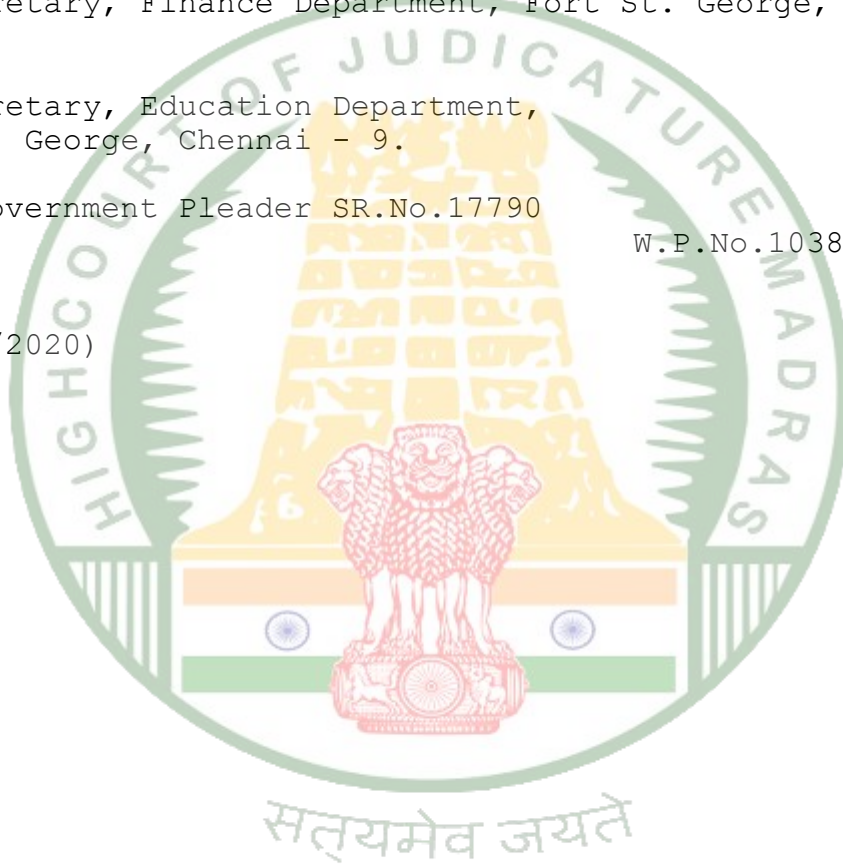
