Prayer:- Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus, calling for the records pertaining to the impugned Termination order issued by the 4th respondent, dated 14.03.2013 based on the letter in Mu.Mu.No.1682/A-1/2012, dated 28.12.2012 of the 3rd respondent and to quash both as illegal and in consequence to direct the respondents to continue as B.T. Assistant at Tamil Nadu Government Scale of Pay for five years either from the date of her joining as a B.T. Assistant on 18.04.2011 or from 01.04.2010 the Right of Children to Free and Compulsory Education Act, 2009, came into force so as to enable her an opportunity to qualify Teacher Eligibility Test under the relevant Act.
