2. This Court, under order dated 22.01.2020, granted leave to the convict Kurudan @ Subramaniam, S/o.Palanisamy Gounder from 23.01.2020 to 03.02.2020 and directed him to return back to the prison on 03.02.2020 at 05.00 p.m.

3.Today, learned Additional Public Prosecutor submits that the convict was taken back to prison on expiry of leave granted to him.

4.Recording the said submission made, the petition stands closed as nothing further survives for adjudication.

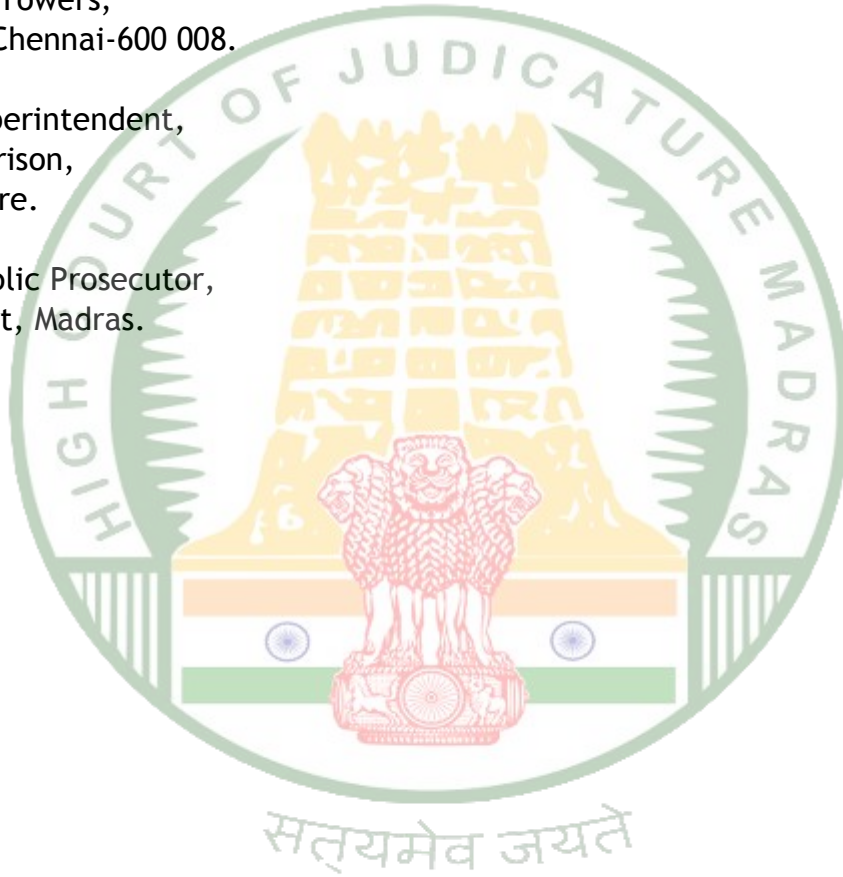

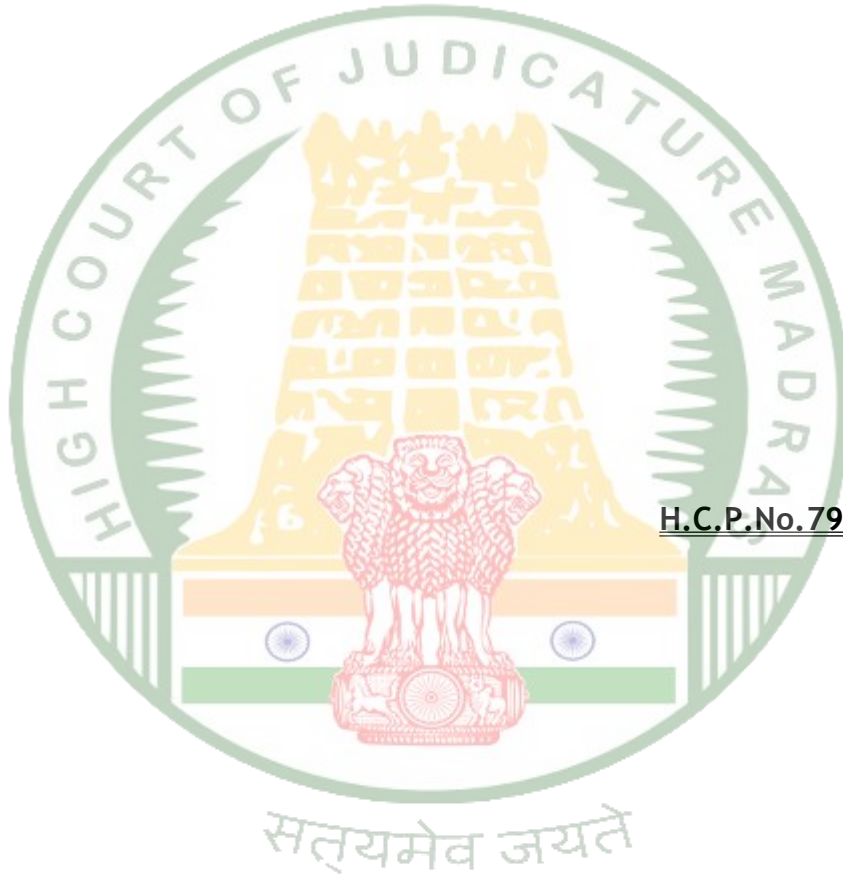
