In all these writ petitions, the petitioner seeks for a mandamus directing the second and third respondents to permit

However, as it is stated that their representation to that effect is still pending and the learned Government Advocate Mr.M.Elumalai appearing for the respondents 2 and 3 also submitted that the said representations would be considered and orders would be passed on merits and in accordance with law, all these writ petitions are disposed of, without expressing any view on the merits of the claim made by the petitioners, only with a direction to the third respondent to consider the representation of the petitioners and pass orders on the same on merits and in accordance with law within a period of two weeks from the date of receipt of a copy of this order.
