PRAYER : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Habeas Corpus calling for the entire records culminating in the passing of the order of detention passed by 2nd respondent dated 07.01.2020 in C3/D.O/01/2020 against petitioner's Son by name C.Sivakumar aged 27 years, S/o. Chinnakkannu who confined at Central Prison, Cuddalore and quash the same as illegal and consequently direct the respondents herein to produce detenue before this Court and set him at liberty.

2.The Petitioner challenges the impugned order of detention in C3/D.O/01/2020 dated 07.01.2020 detaining her son as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

3.The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O. Rt. No. 810, Home, Prohibition and Excise (XI) Department, dated 17.02.2020 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition is dismissed as infructuous.
