The petitioner has filed this writ petition seeking issuance of Writ of Mandamus directing the respondents to sanction the incentives, increments and part final payment of the Provident Fund amount, to the petitioner based on the representation dated 08.04.2013.

2.The case of the petitioner is that the petitioner made representation to the respondents seeking to sanction incentives and increments for completing the Master Degree and since the same has not been considered, has filed this writ petition.

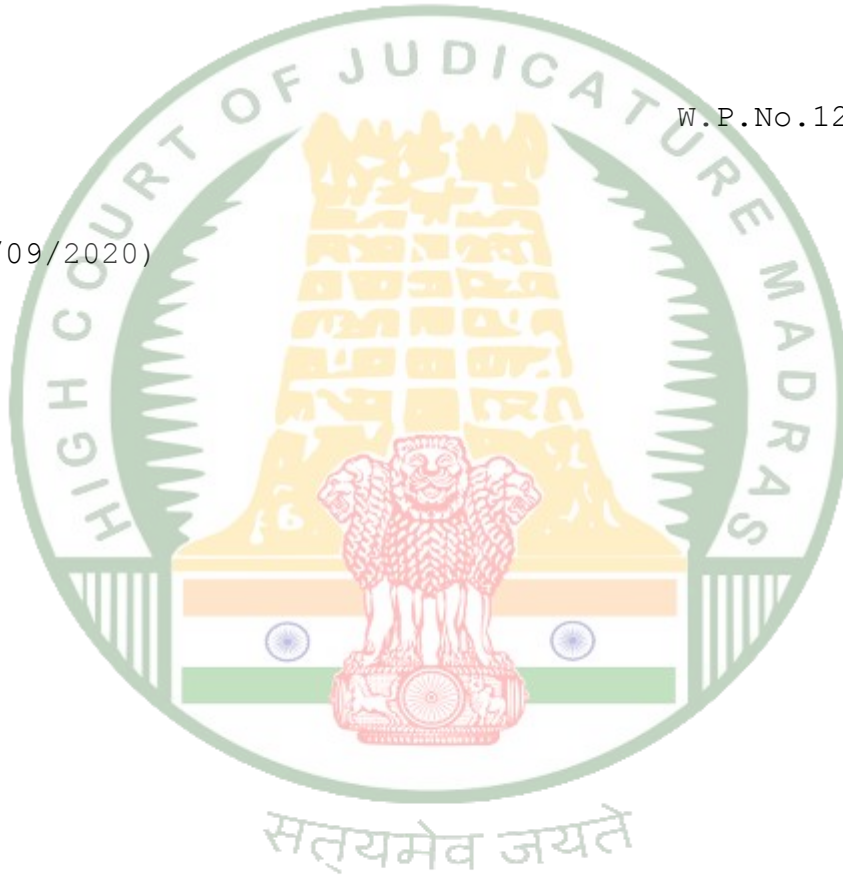
