PRAYER : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Habeas Corpus calling for records pertaining to the detenu Mr.Krishnan @ Ondiveeran son of Mr.Thiruman, who is detained under Tamil Nadu Act 14 of 1982 as GOONDA at Central Prison, Coimbatore, by the second respondent herein vide his order in Cr.M.P.No.29/Goonda/2019 dated 12.12.2019 on the file of the second respondent herein and to quash the same and direct the respondent herein to produce the body of the detenu Mr.Krishnan @ Ondiveeran son of Mr.Thiruman, aged about 50 years and set him at liberty.

2.The Petitioner challenges the impugned order of detention in Cr.M.P.No.29/Goonda/2019 dated 12.12.2019 detaining her husband as "Goonda", as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

3.The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O. Rt. No.416, Home, Prohibition and Excise (XII) Department, dated 23.01.2020 and he has also produced a copy of the Government Order. Recording the same, this Habeas Corpus Petition is dismissed as infructuous.
