PRAYER : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Habeas Corpus, calling for the records pertaining to the order of detention passed by the second respondent in Order No.849/BCDFGISSSV/2019 dated 10.12.2019 set aside the same, direct the 2nd respondent to produce the petitioner's grand son, the detenu Thiru Sudhakar @ Jilo Sudhakar, S/o.M.Murugan, aged about 26 years, and presently detained in Central Prison at Puzhal, Chennai before this Court and set him at liberty.
