This Writ Petition has been filed challenging the order passed by the first respondent dated 29.11.2002 in Ref.No.Na.Ka.No.36132/C2 section/C5/2002 and quash the same in so far as it relates to inclusion of respondents 2 to 6 and further direct the 1st respondent to include the name of the applicant in the said panel and to award the consequential benefits.

2. It is averred in the writ petition that the petitioner has filed Original Application in O.A.No.2044 of 2003 before the Tamilnadu Administrative Tribunal, Chennai. Subsequently, due to abolition of Tribunal, the matter has been transferred to this Court and renumbered as W.P.No.16537 of 2007. This Writ petition has been filed questioning the inclusion of the respondents 2 to 6 and further seeks direction to the 1st respondent to include the name of the applicant/petitioner in the said panel and to award the consequential benefits.

3. When the matter was taken up today, none appeared on behalf of the petitioner.

4. The learned Additional Government Pleader, on instructions filed proceedings of Joint Director (Personnel) of School Education, Chennai-6, signed on 26.09.2019, wherein it is stated that the petitioner has already been considered in the panel and promoted and also now retired from service.

5. In view of the above, the relief sought for in the Writ Petition had already been implemented by the Government.

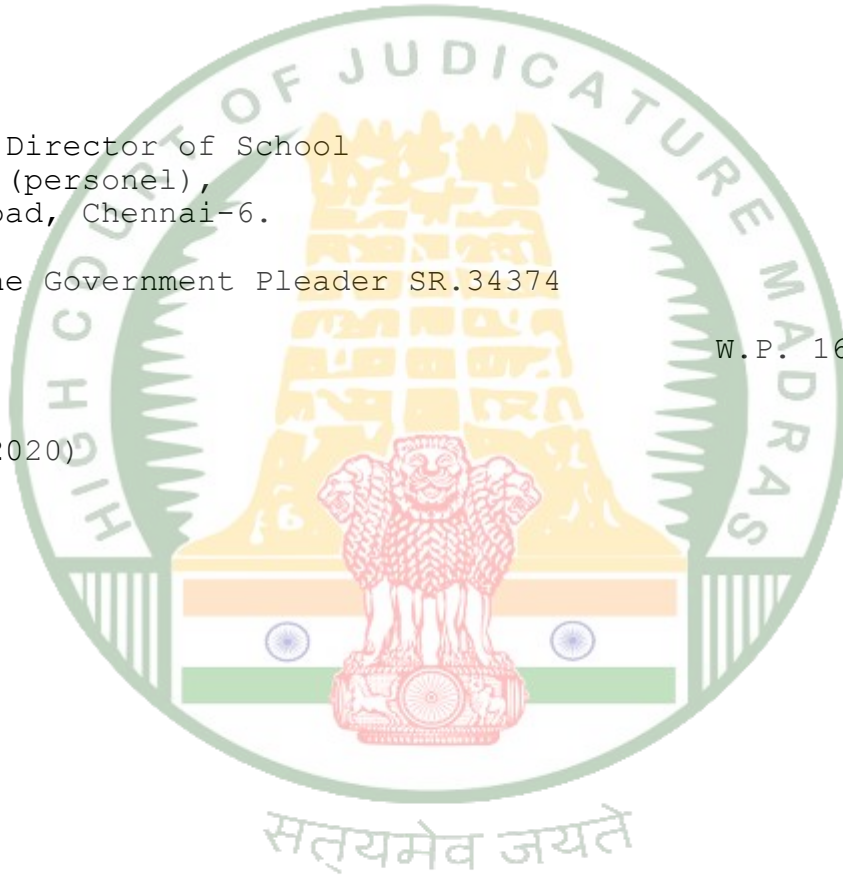
