“to call for the records in Complaint dated 12.09.2018 filed by the Respondent against the Petitioner before the Additional Chief Metropolitan Magistrate, Egmore, Chennai in E.O.C.No.266 of 2018 and renumbered as C.C.No.15 of 2019 and pending in the Special Court for trial of Criminal Cases Related to MPs/MLAs of Tamil Nadu, Singaravelan Maaligai, Chennai and quash the same.”

and thus render justice.”

2 Learned counsel for respondent submits that instant four Crl.M.Ps are not opposed. In the light of the stated position of the

respondent, no discussion or dilation of facts are necessary. Suffice to say that on perusal of affidavits filed in support of Crl.M.Ps, this court is convinced that prayers are not only innocuous, but imperative and therefore, prayers in instant four Crl.M.Ps are acceded to. In other words, instant four Crl.M.Ps are allowed. Registry to carry out necessary and consequential amendments in case file on or before 18.02.2020.

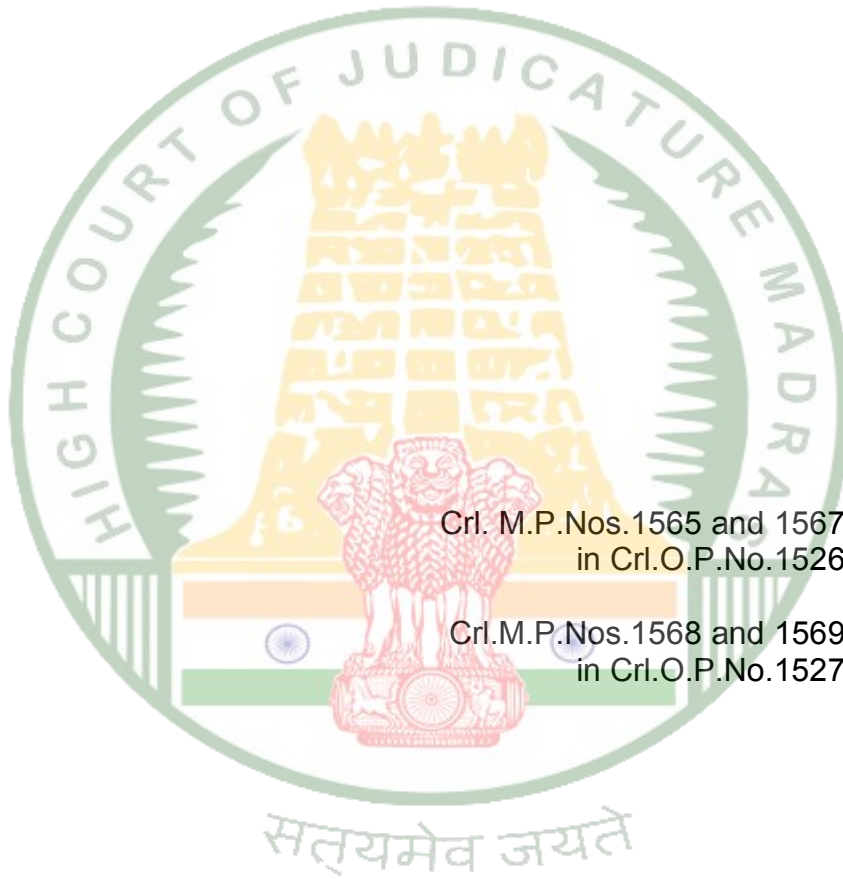
