PRAYER : Originally this petition has been filed as Original Application No.5379 of 2002 before the Tamil Nadu Administrative Tribunal at Chennai and after abolition of TNAT, petition has been transferred and numbered as W.P.No.13304 of 2006.

Writ petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus to direct the respondents 1 to 3 to promote the petitioner to the post of Assistant Executive Engineer retrospectively with effect from 11.05.1988 on par with his juniors with all monetary benefits and arrears and other consequential service benefits.

ORDER

This Writ Petition has been filed to direct the respondents 1 to 3 to promote the petitioner to the post of Assistant Executive Engineer retrospectively with effect from

2. When the matter is taken up for hearing today, there is no representation on behalf of the petitioner. On an earlier occasion, this Court directed to issue fresh notice to the correct address of the petitioner as given by the learned Special Government Pleader and the same is served to the petitioner. 3. Even after serving several notices on the petitioner, there is no representation on behalf of him. Accordingly, since the matter is pending from the year 2006, this Writ Petition is dismissed for non-prosecution. No costs.
