Jayaprakash Narayanan, Learned Government Pleader takes notice for the Second to Fourth Respondents, and perused the materials placed on record, apart from the pleadings of the parties.

The Petitioners have been elected as Ward Councilors in Thiruvallangadu Panchayat Union and they seek directions in these Writ Petitions to consider their representations made for police protection during the election to be held on 30.01.2020 to the posts of Chairman and Vice-Chairman of Thiruvallangadu Panchayat Union.

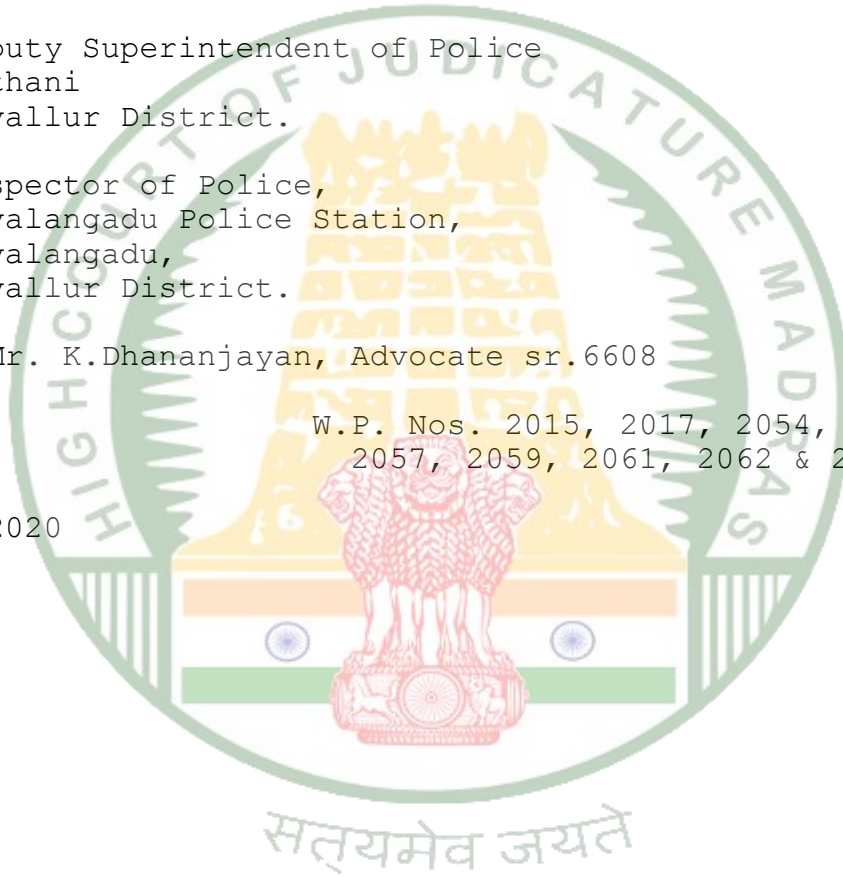
