ORDER

This writ petition has been filed by the petitioner to call for the records of the 2nd respondent in Memo No.2387/PS4/TNSTC (VPM-DVN.II)/2003 dated 25.6.2003 and quash the same.

By Memo No.2387/PS4/TNSTC (VPM-DVN.II)/2003 dated 25.6.2003, the second respondent transferred the petitioner from Arni Depot to Tirupattur-II Depot and also requested the Branch Manager, Arni Depot to relieve the petitioner immediately with direction to report for duty before the Branch Manager, Tirupattur-II, Depot forthwith without waiting for a substitute. Challenging the said transfer order, the petitioner filed this

present writ petition.

3. Now the learned counsel for the second and third respondents would submit that the petitioner had already relieved from Arni Depot and joined duty in Tirupattur -II Depot and therefore, nothing survives for further adjudication.

4. Recording the same, this writ petition is dismissed as infructuous. No costs.
