The Writ petition has been filed praying to issue a Writ of Certiorarified Mandamus or any other writ or order in the nature of writ calling for the records on the file of the 1<sup>st</sup> respondent and quash the order passed by the 1<sup>st</sup> respondent in proceedings no.E2/1214/2006/H dated 31.07.2007 dismissing the petitioner from service.

When the matter came up for hearing today, it is represented by the learned counsel for the respondents 1 & 2 that pending disposal of the writ petition, the writ petitioner died on 20.1.2009 itself but, till date no legal representative was brought on record since they are not interested to proceed the case further. Therefore, the writ petition has to be dismissed as abated. In this regard, Death Certificate of the Deceased and letters received from the wife of the deceased have been submitted before this Court.

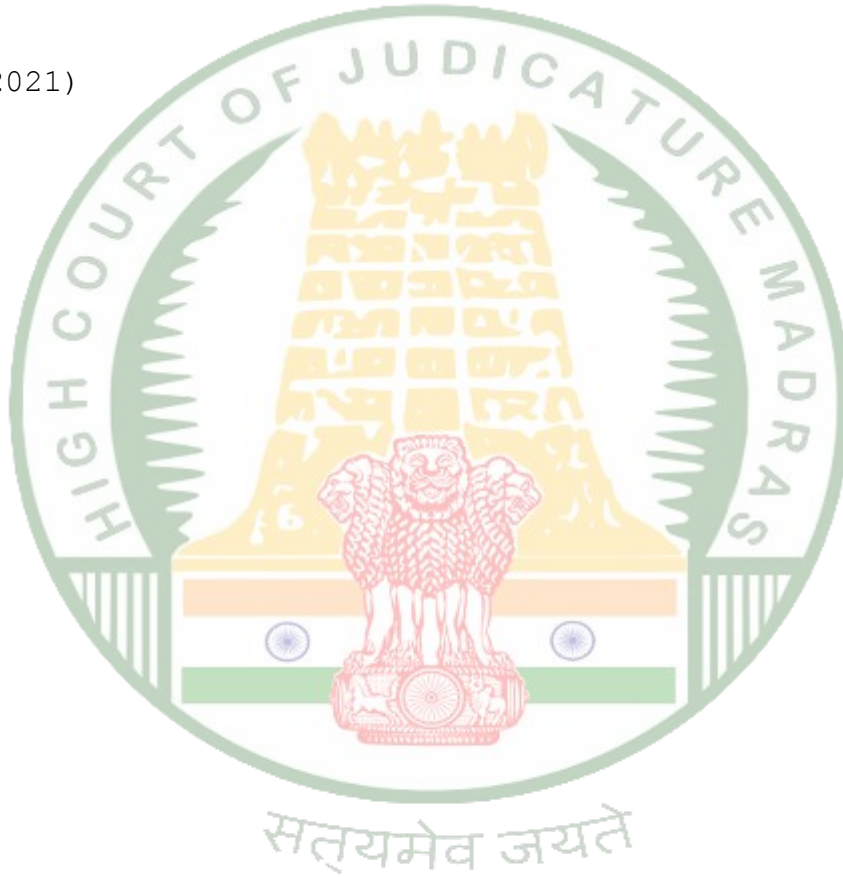
