D.George with all consequential service and monetary benefits, came on transfer and renumbered as the present writ petition.

2.When the matter is taken up today, Mr.K.Mahesh, the learned Special Government Pleader would submit that the issue decided in favour of Mr.D.George was reversed by order dated 11.09.2002 passed by a Division Bench of this Court in W.P.No.3159 of 1999. Further, the identical issue filed by the petitioners in W.P. Nos.19374 and 12447 of 2007 were also

dismissed by this Court citing the order of the Division Bench of this Court.

3. In view of the aforesaid submissions made by the learned Special Government Pleader, as per the order dated 11.09.2002 passed by this Court, the Writ petition is dismissed. No Costs.

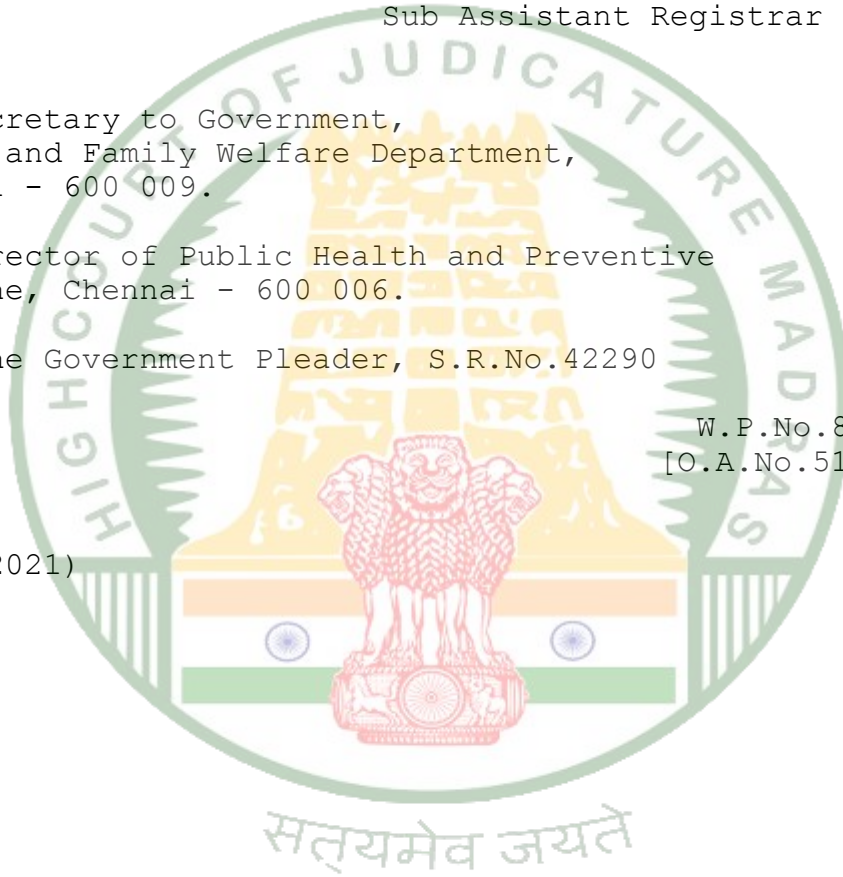
