By the common judgment dated 17.07.2020, this Court allowed the C.M.A.Nos.3459 & 3460 of 2013 with a direction to the Principal District Judge, Motor Accidents Claims Tribunal, Namakkal, to dispose of M.C.O.P.Nos.398 & 663 of 2007 within a period of six months from the date of receipt of a copy of that common judgment.

2.The learned Principal District Judge, Namakkal, by a letter to the Registry dated 25.10.2021, seeks two months time to dispose of M.C.O.P.Nos.398 & 663 of 2007 on the ground that the cases are posted for filing counter statement by the proposed party, who is the owner of offending vehicle.
