ORDER

4. With the above direction, this Petition is closed.

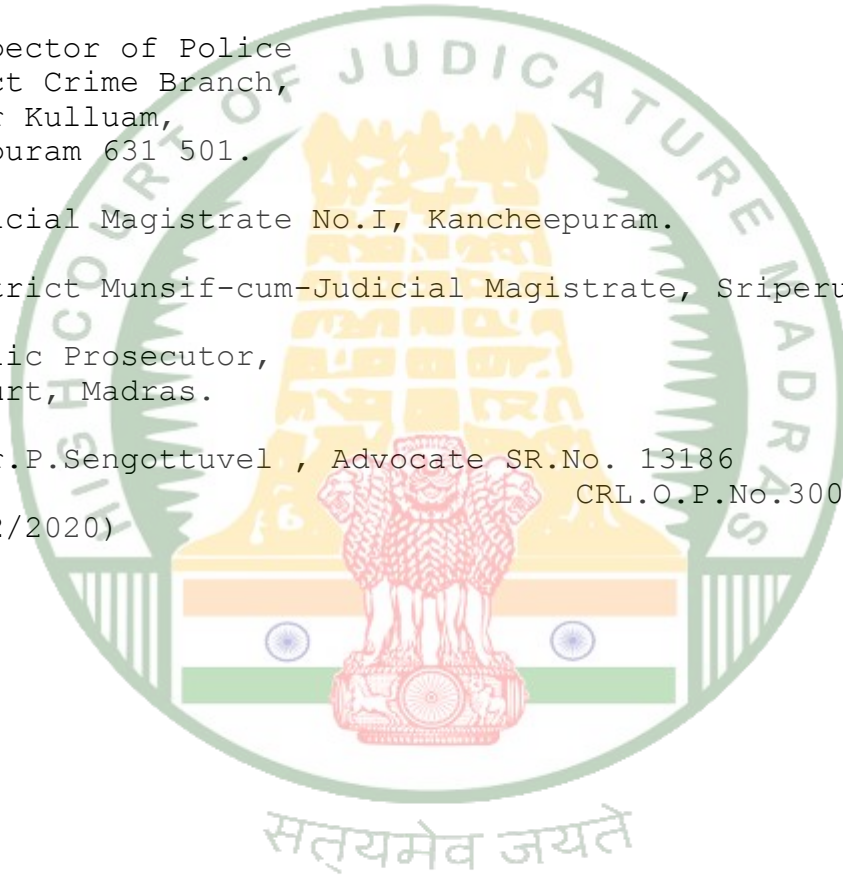
