The petitioner herein filed a petition in Crl.M.P.No.12415 of 2016 praying for suspending the sentence imposed on him by the learned Judicial Magistrate No.IV, Coimbatore in C.C.No.56 of 2001, by judgment dated 15.04.2015, which has been confirmed by the learned I Additional District and Sessions Judge, Coimbatore by judgment dated 02.08.2016 in Crl.A.No.99 of 2015. This Court, by order dated 01.12.2016, passed an order suspending the sentence imposing certain conditions. Now, the present petition has been filed to relax the condition imposed against the petitioner as regards appearance of the petitioner before the Trial Court.

2.The learned counsel for the petitioner has submitted that the petitioner is regularly complying with the conditions imposed by this Court without fail for more than three years and hence, the condition imposed against the petitioner as regards appearance of the petitioner before the Trial Court, may be relaxed. The learned Additional Public Prosecutor has not seriously opposed the said
