Petition under Article 226 of the Constitution of India praying for issuance of Writ of Certiorarified Mandamus, calling for the records relating to the proceedings of the 1st respondent made in Ni.Mu.Pa.Maa 1499/6II/2012-2013 dated 25.05.2012 and quash the same and further direct the first respondent to transfer the patta in the name of the petitioner in respect of survey nos.43/12C, 14, 15, 44/2 in patta no.36, Survey Nos. 183/3, 80/10, 80/2, 80/6, 97/2 in patta no.37 and survey no.87/7 in patta no.816, survey no.80/4 in patta no.838 and survey nos. 43/7C, 9B2 and 9C2 in patta no.848 in Vagurampatty village, Namakkal Taluk and district.

Heard Mr.T.Dhanyakumar, learned counsel for the petitioner and Ms.A.Madumathi, learned special government pleader for the first to third respondents.

2. The petitioner has impugned the proceedings of the first respondent dated 25.05.2012, by which the petitioner's application for grant of patta has been rejected to enable the petitioner to produce the legal heirship certificate and other records so that the authority can consider the application on merits. However, instead of re-submitting the application the petitioner has come to this Court seeking to quash the impugned proceedings. The impugned proceedings is not an order, only an intimation to the petitioner calling upon him to produce the necessary records.

3. Therefore, the writ petition stands disposed of by directing the petitioner to resubmit the application along with all documents called for and if the petitioner resubmits the application, the respondents shall consider the same and pass orders on merits and in accordance with law. No costs.
