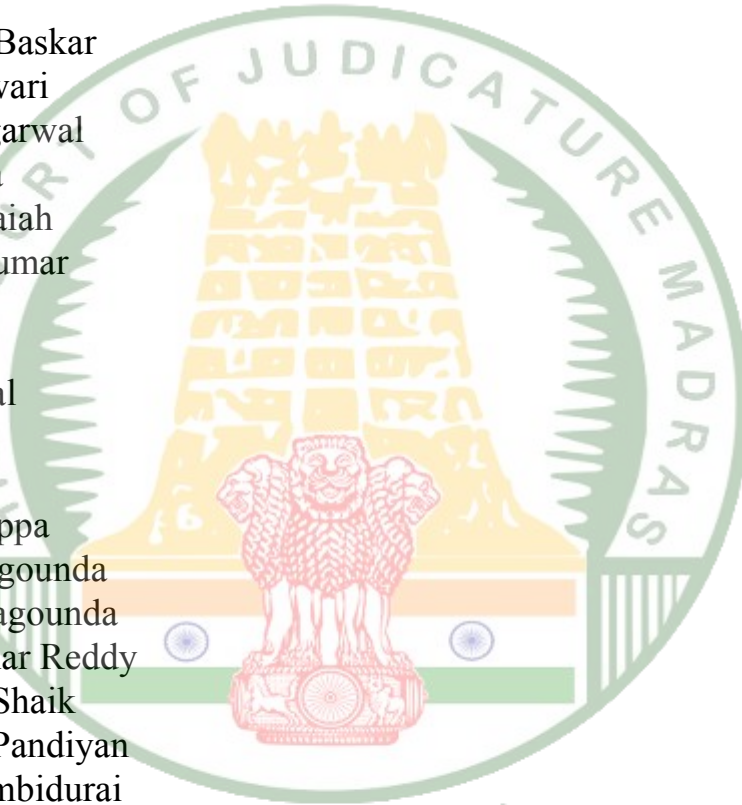

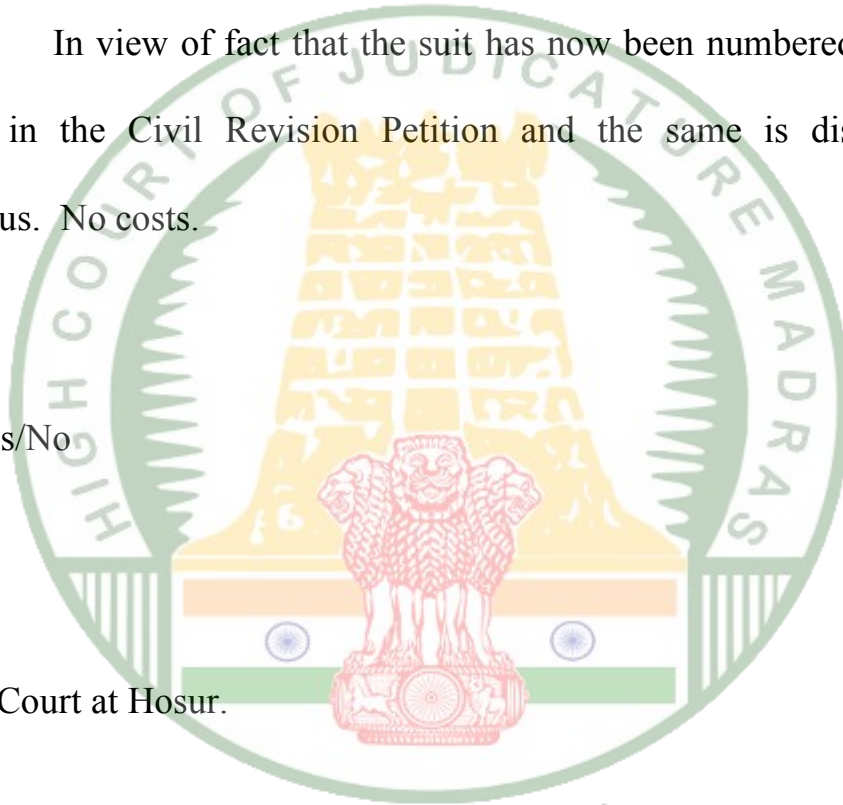
2. The learned counsel for the petitioners submit that the suit was numbered. Therefore, the civil revision petition has become infructuous.
