4. When the matter was taken up for hearing, the learned Government Advocate (Crl. Side) submitted that on the complaint given by one Nadhiya against Selvi, the 2nd petitioner herein, petition enquiry was conducted in C.S.R.No.157 of 2018 and the same was closed on 28.04.2018.

5. This Court has dealt with the question of "not to harass" at length and passed a detailed order in Dorand and Others Vs the Superintendent of Police, Nagercoil, Kanyakumari District and another¹.

Hence, this criminal original petition is dismissed.
