The petitioner has filed the present writ petition seeking a direction to the first respondent to dispose of his representation dated 13.12.2019.

4. The learned counsel for the second and third respondents would submit that the petitioner was already suspended from the diocese and he has no locus standi to ask for the details. It is open to the second respondent to produce all the accounts, so that the first respondent will process the contribution details in accordance with law.

5. Considering the factual circumstances, a direction is given to the first respondent / Regional Provident Fund Corporation authority to conclude the Section 7 A of the Enquiry under Section EP and NP Act, 1932, within a period of two months and pass orders. It is open to the parties to agitate the matter, if so aggrieved.

Accordingly, the writ petition is disposed of. No costs.
