Petition filed under Article 226 of the Constitution of India for issuing a writ of mandamus directing the transfer of Crime No.21 of 2012 on the file of the District Crime Branch, Villupuram to the Central Bureau of Investigation or to any other independent agency; to direct the District Collector, Villupuram/1<sup>st</sup> respondent from revoking the suspension made in A6/2677/2012-1 dated 07.09.2012 issued against Thiru.K.Elumalai;

to place M.Venkatesan, the then Block Development Office (Scheme) presently working as Block Development Officer, Vanur Taluk, Villupuram District under suspension and to take appropriate departmental action besides initiating criminal prosecution against him; to restrain the 1<sup>st</sup> respondent from taking any further action against the petitioner pursuant to the proceeding Dt.28.05.2013 made in A6/2677/2012 till the disposal of the Crime No.21/2012 and Crime No.9/13 on the file of the District Crime Branch Villupuram.

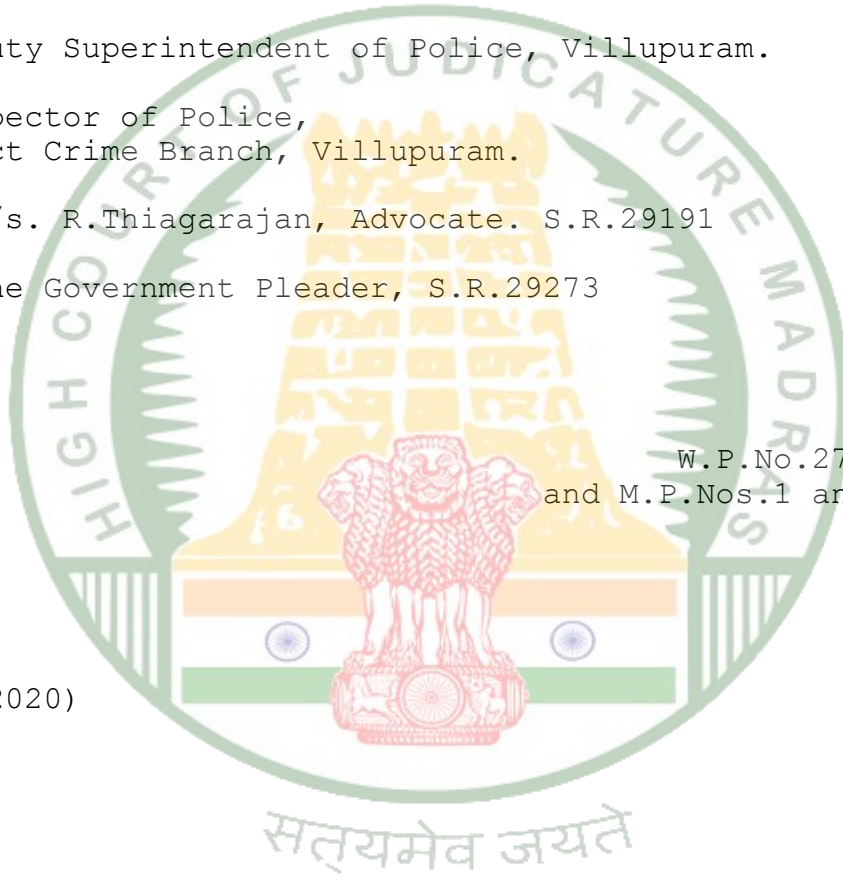
