This writ petition has been filed for issuance of a writ of mandamus directing the respondents to survey and measure the property and make necessary rectification in the revenue records based on the representation made by the petitioner on 11.06.2019.

3.In view of the above development, there shall be a direction to the 2nd respondent to complete the enquiry and pass appropriate orders strictly in accordance with law, within a period of six weeks from the date of receipt of copy of this order. The 2nd respondent shall hear all the parties concerned before taking the final decision.
