"Petitioners shall stay at Trichy and report before the Town Police Station, Town Hall, Trichy daily at 10.00 until further orders."

2.The learned counsel appearing on behalf of the petitioners would submit that as per the earlier order passed by this Court on 22.11.2019 in CrI.M.P.No.15239 of 2019 in CrI.A.No.735 of 2019, the petitioners have complied with the conditions imposed regularly. Mr.R.Prathap Kumar, learned Additional Public Prosecutor would also confirm the same.

3.Therefore, the condition imposed on the petitioners directing them to stay at Trichy and report before the Town Police Station, Town Hall Trichy daily at 10.00 until further orders alone is modified to the following effect:

"Petitioners shall report before the III Additional Sessions Judge, Tiruvallur @ Poonamallee on the first working day of every month until further orders."

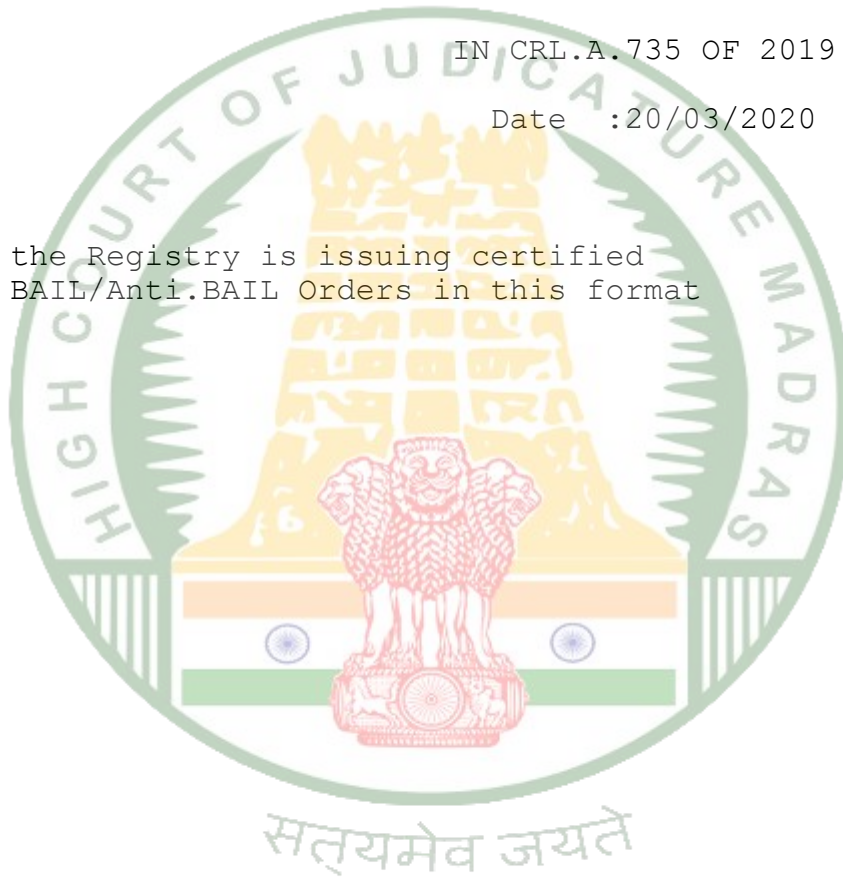
