This petition has been filed to modify the condition imposed on the petitioner in Crl.M.P.No.1399 of 2020 in Crl.O.P.No.33903 of 2019 on 04.02.2020 to report before the respondent police on every Monday at 10.30 a.m., until further orders.

2.The learned counsel for the petitioner submitted that pursuant to the order of this Court dated 19.12.2019 in Crl.O.P.No.33903 of 2019, the petitioner stayed at Madurai and signed before the Inspector of Police, Thallakulam Police Station, Madurai for a period of 30 days and the said order was modified by an order dated 04.02.2020 in Crl.M.P.No.1399 of 2020 in Crl.O.P.No.33903 of 2019 and

the petitioner was directed to report before the respondent police on every Monday at 10.30 a.m., until further orders. He further submitted that the petitioner has some difficulty in complying with the said condition and seeks to modify the said condition.

3.Considering the said submission, the condition imposed as against the petitioner is modified to the effect that the petitioner shall report before the Judicial Magistrate -I, Walajah on every Monday at 10.30 a.m., until further orders.
