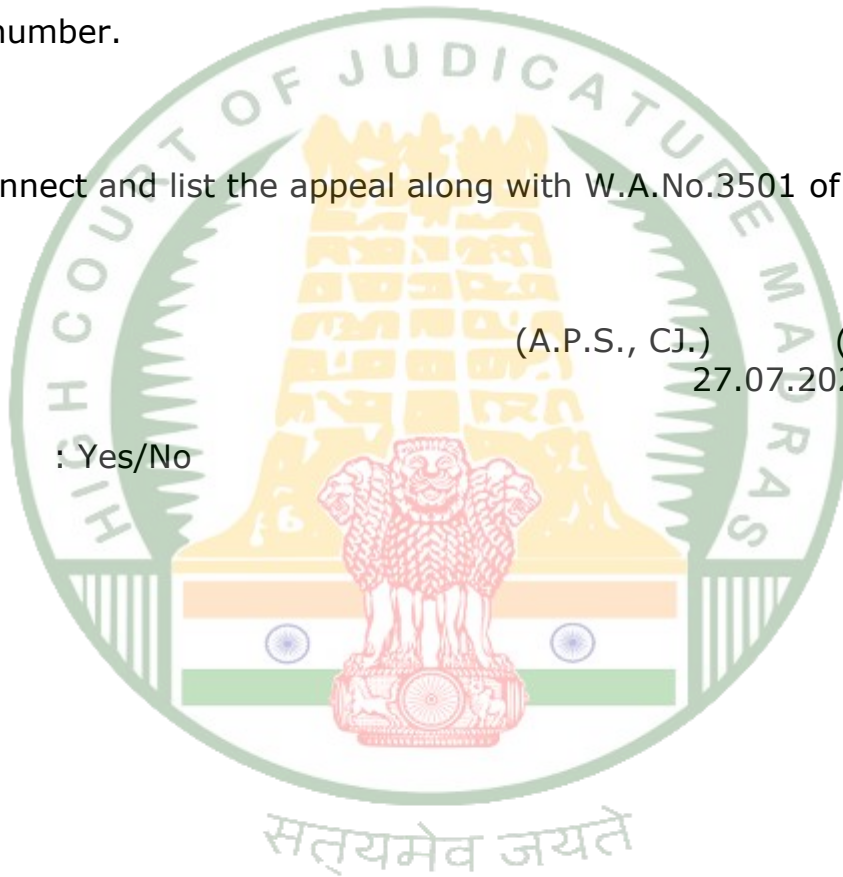
application are sufficient to condone the delay. Accordingly, the delay is condoned and the petition is allowed.
