The learned counter for the petitioner submitted that when the petitioner was in the process of complying with the earlier condition imposed by this Court, Vide its order dated 19.02.2020, the petitioner encountered an incident on 02.3.2020, by which, some of the police personnel attached to the respondent-police tried to implicate him in another case. The learned counsel for the petitioner submitted that the petitioner has been secured.

3. Heard the submission of the learned Government Advocate (Criminal Side) appearing for the respondent.

4. Considering the submissions made by the learned counsel appearing for the petitioner, the condition imposed as against the petitioner in Crl.OP.No.3542 of 2020, is modified to the effect that the petitioner shall now appear and sign before the concerned Judicial Magistrate Court.
