5. The name of Mr.M. Raghavan shall also be shown in the cause list as learned counsel for the respondents.

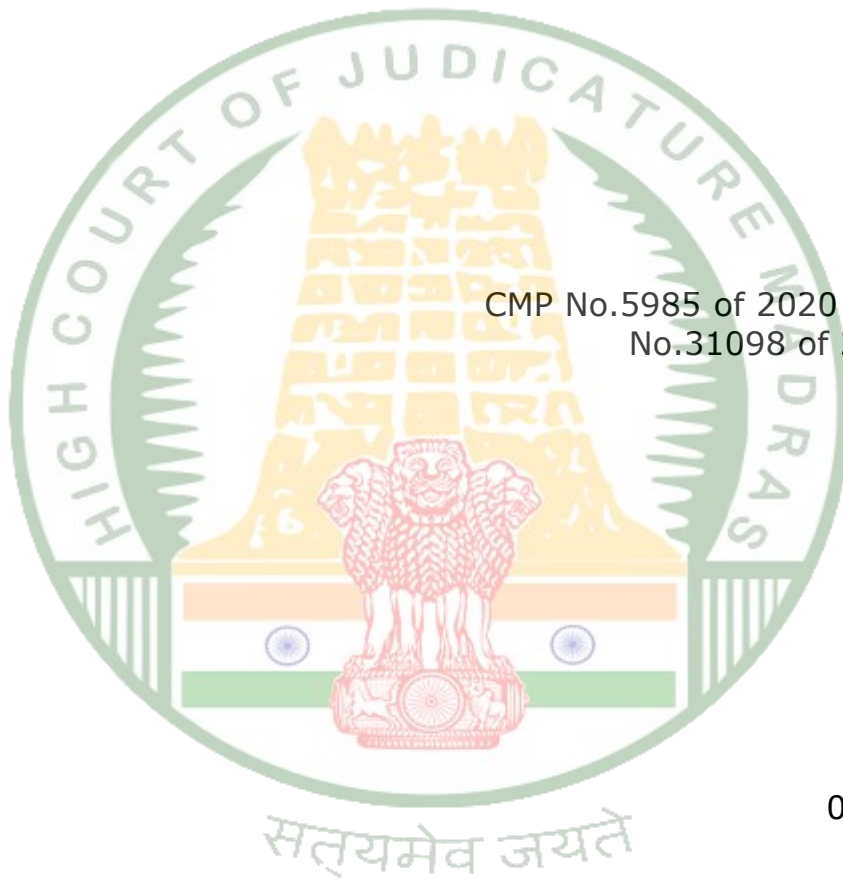
