to give refund/adjustment of the amount already collected from the petitioner.

This writ petition has been filed by the petitioner seeking for issuance of a writ of certiorarified mandamus to call for the records of the 4th respondent in his Bill No.101 dated 30.01.2012 in so far as it relates to levy of penalty in the form of excess demand charges of Rs.88,549.80/- in Serial No.13 (f) of the said Bill, quash the same as illegal, arbitrary, without the authority of law and consequently forbear the 4th respondent from taking energy adjusted instead of energy available to the credit of the petitioner for the purpose of equivalent demand calculation till the power cut, load shedding are in force and consequently direct the 4th respondent to give refund/adjustment of the amount already collected from the petitioner.

2. When the matter is taken up for hearing, the learned counsel for the petitioner submitted that the matter is pending before the Appellate Tribunal for Electricity.

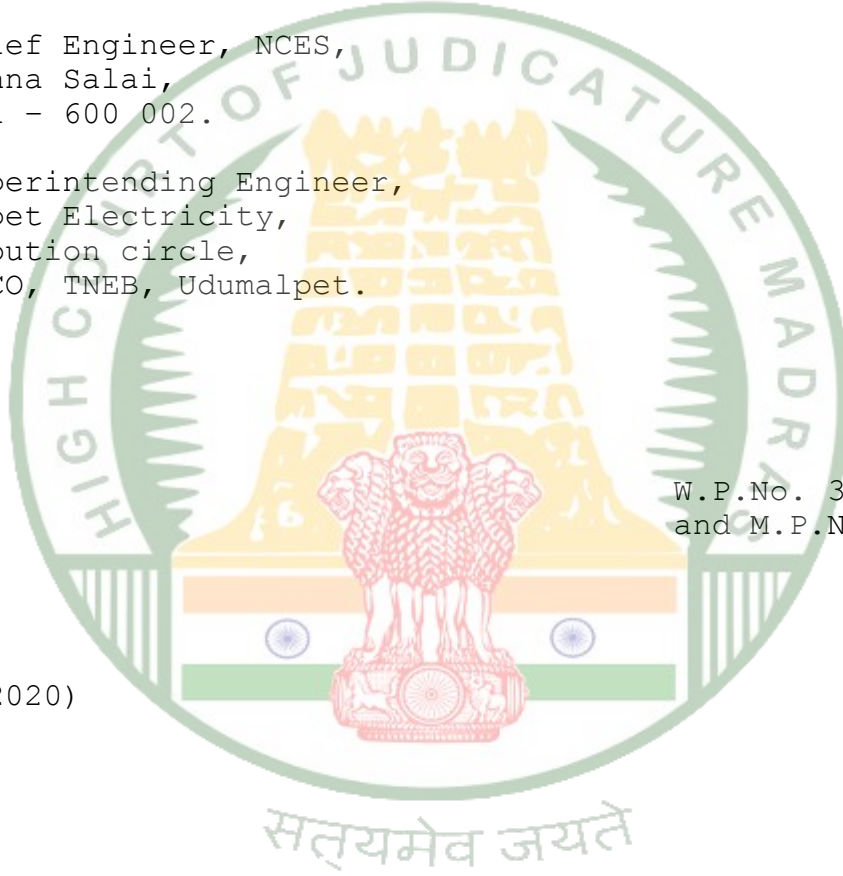
