the applicant company.

**Prayer in OA 237 of 2019:** Original application filed under Order XIV Rule 8 of O.S.Rules read with Section 9 of the Arbitration and Conciliation Act, 1996 to grant interim injunction restraining the respondent to directly or indirectly solicit or attempt to solicit any business from any of the company's customers, customer prospects, or vendors with whom he had Material contact during the employment with the company and to directly or indirectly use or disclose any confidential protected health and potential business information pertaining to the company, including but not limited to trade secrets, technical data, business operations or internal structure of the company, the financial condition of the company, the customers and / or inventor lists of the company, the Statutory, salary, staffing and other department information.

**Prayer in A.No.1894 of 2019:** Original application filed under Order XIV Rule 8 of O.S.Rules read with Section 9 of the Arbitration and Conciliation Act, 1996 to grant interim order directing the respondent to specifically deliver all the property and material of the applicant company which are in his possession and to restrict or prohibit use of the same, until custody of the same is returned to the applicant company.

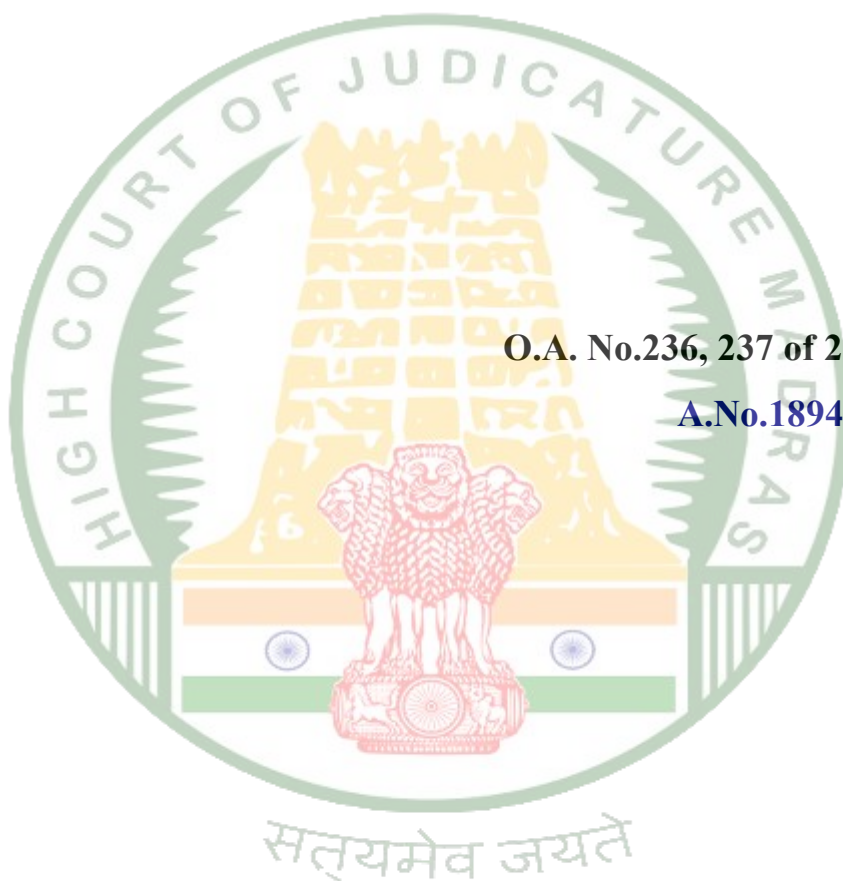
