**Prayer in OA 247 of 2019:** Original application filed under Order XIV Rule 8 of O.S.Rules read with Section 9 of the Arbitration and Conciliation Act, 1996 to grant interim injunction restraining the respondent to directly or indirectly render any service of a business or commercial nature by continuing his employment with the applicant companies vendor, M/s MBF Digital Production Services Pvt Ltd. Until completion of the Arbitration proceedings, and to recruit, solicit or induce or attempt to recruit, solicit, or induce any employee of the company with whom he had personal contact or supervised while performing his job

duties during the employment with the applicant company.

**Prayer in OA 248 of 2019:** Original application filed under Order XIV Rule 8 of O.S.Rules read with Section 9 of the Arbitration and Conciliation Act, 1996 to grant interim injunction restraining the respondent to directly or indirectly solicit or attempt to solicit any business from any of the company's customers, customer prospects, or vendors with whom he had Material contact during the employment with the company and to directly or indirectly use or disclose any confidential protected health and potential business information pertaining to the company, including but not limited to trade secrets, technical data, business operations or internal structure of the company, the financial condition of the company, the customers and / or inventor lists of the company, the Statutory, salary, staffing and other department information.

**Prayer in A.No.1910 of 2019:** Original application filed under Order XIV Rule 8 of O.S.Rules read with Section 9 of the Arbitration and Conciliation Act, 1996 to grant an interim order directing the respondent to deposit in a scheduled bank a sum of Rs.7,58,620/- (Seven lKhs fifty eight thousand six twenty rupees only) as security for the outstanding loan amount, availed by the respondent on the applicant companies account.

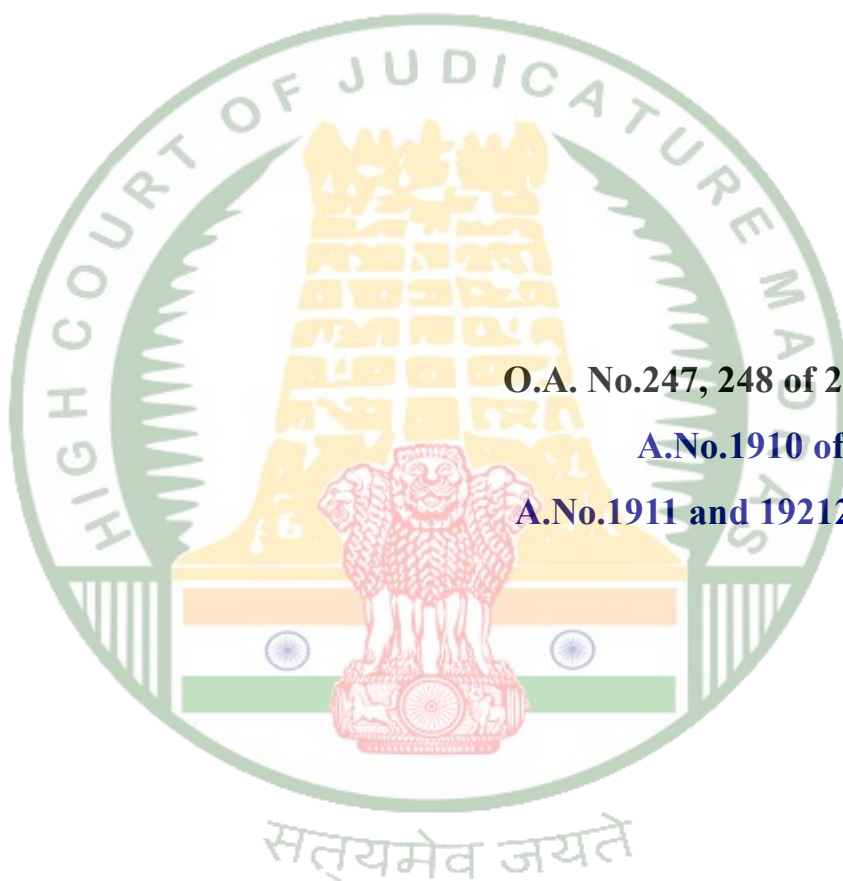
