ORDER

Appellant and his counsel are present. Eventhough the respondents 1 and 2 officials of the Revenue Department are printed in the today's cause list, they are not present. Even in the previous hearing date i.e. on 18.02.2020 respondents 1 and 2 officials were not present eventhen the appellant was present. This is an appeal preferred by the appellant /

claimant for enhancement of the award amount passed by the Tribunal in LAOP.NO.75 of 2014 dated 27.11.2017. The learned counsel for the appellant requests to permit in not pressing / dismissing the appeal and made an endorsement to dismiss / not press the appeal as withdrawn and requests to refund in full court fees. This is an appeal preferred by the appellant / claimant for enhancement and in the abovesaid circumstances for not pressing / dismissing the appeal, the presence of respondents 1 and 2 officials are not necessary and there is no legal impediment in withdrawing the appeal as not pressed as requested by the appellant.
