There shall be an order of interim stay to stay the operation of the impugned proceedings of the 5th respondent in his Letter No.AEE/O and M/KNPuram/P.LTCT/A.No.06/19-20 dated 21.02.2020 subject to the condition that the petitioner deposits a sum of Rs.10,00,000/-(Rupees Ten Lakhs Only) within a period of four(4) weeks from the date of receipt of copy of this order.

3. It is made clear that if the petitioner fails to comply with this condition, the stay shall stand automatically vacated without any further reference to this Court.

4. Accordingly, the miscellaneous petition is disposed of.

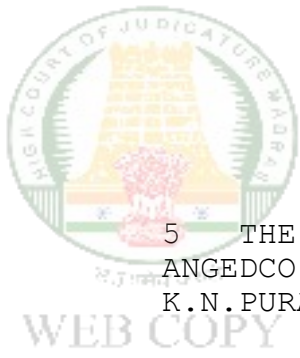
