Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, to direct the respondents the Collector of Chennai and the Thasildar Fort Tondiarpet, Chennai - 81, to consider the application/requisition of the petitioner G.Marthal to effect changes in the name of the holder of the Patta, removing the name of Mrs.Kanchana John Bosco and enter the name of the petitioner as the owner of the property land in the Patta register. ORDER

This Writ petition has been filed for the issuance of Writ of Mandamus directing the respondents to effect the changes in the revenue register and enter the name of the petitioner as the owner of the property.

2.A Status report has been submitted by the second respondent, wherein it is stated that already two hearings have been held and the third enquiry is posted on 19.03.2020. The learned Additional Government Pleader appearing on behalf of the respondents 1 and 2 submitted that after final enquiry, final orders will be passed within the time fixed by this Court.

3.Taking into consideration, the above development, this Writ petition is disposed of with a direction to the second respondent, to complete the enquiry and forward his report to the Revenue Divisional Officer, Tondiarpet and thereafter, the Revenue Divisional Officer, Tondiarpet shall pass final orders. This process shall be completed within a period of six weeks from the date of receipt of a copy of this order.

4.With these observations, the Writ petition is disposed of. No costs.
