PRAYER: Criminal Original Petition filed under Section 482 of the Code of Criminal Procedure, to issue direction to the second respondent to give the Bandobust for permission to conduct the cultural programme on 01.04.2020 at 6.00 PM to 11 PM in the event of Arulmighu Sri Pudhu Mariamman Koil at Rajaji, Odappalli Agraharam, Cauvery Railway Station, Namakkal District - 638 007 based on the petitioner's representation dated 16.03.2020.

ORDER

The petitioner has come up with this Criminal Original Petition to direct the second respondent to grant permission and protection to conduct the cultural programme scheduled to be held on 01.04.2020 in Arulmighu Sri Pudhu Mariamman Koil situated at Rajaji, Odappalli Agraharam, Cauvery Railway Station, Namakkal District - 638 007 based on his representation dated 16.03.2020.

2.When the matter was taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the respondents drew the attention of this Court to Clause-14 of the order passed by the Government of Tamil Nadu in G.O.(Ms.)No.347, Public Health and Welfare Department dated 16.03.2020 wherein it is stated that permissions should not be granted to conduct

processions, meetings, summer classes, camps, business exhibitions, games and any other similar types of programmes involving large number of people till 31.03.2020. Pointing out to the same, she submitted that the petitioner is not entitled to seek the relief as prayed for in this Criminal Original Petition.

3.The learned counsel for the petitioner has also accepted the same and made an endorsement in the case bundle that he may be permitted to withdraw this Criminal Original Petition.

4.In view of the above, the Criminal Original Petition is dismissed as withdrawn.
