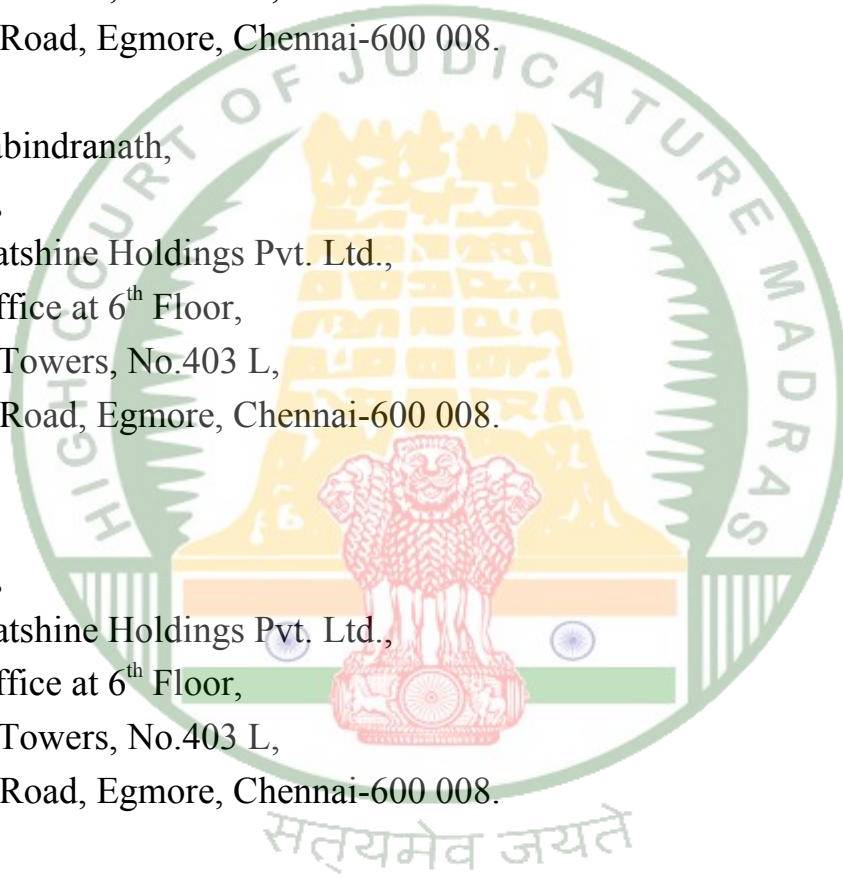

2. In view of the submission of the learned counsel appearing for the applicant and memo sent through e-mail, this application is dismissed as withdrawn.

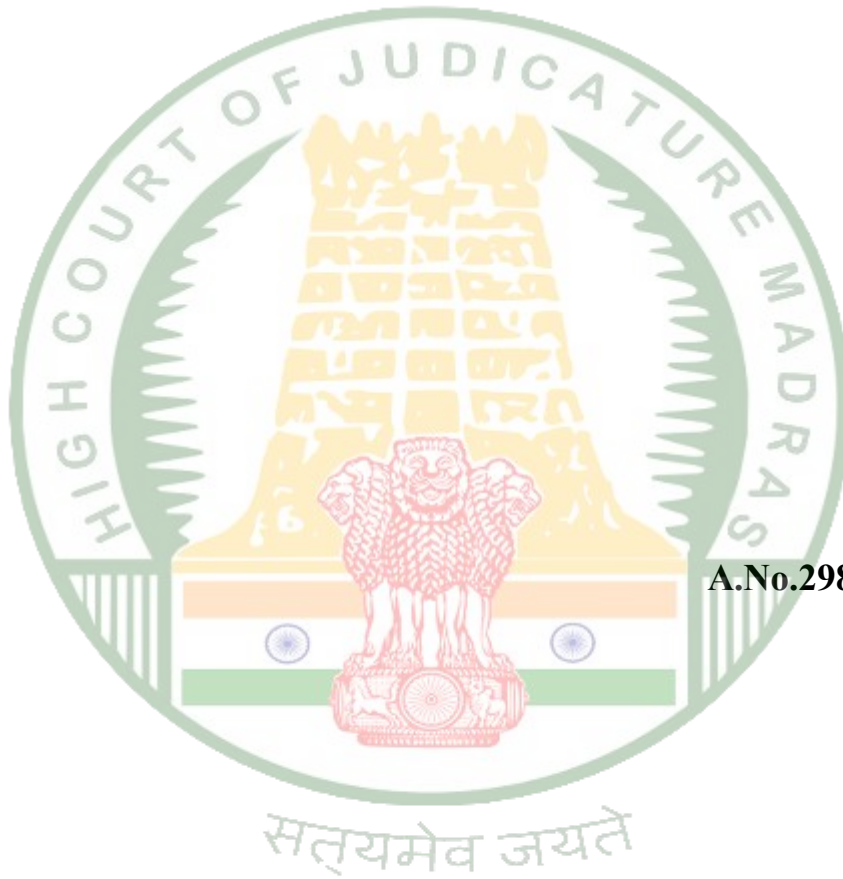
