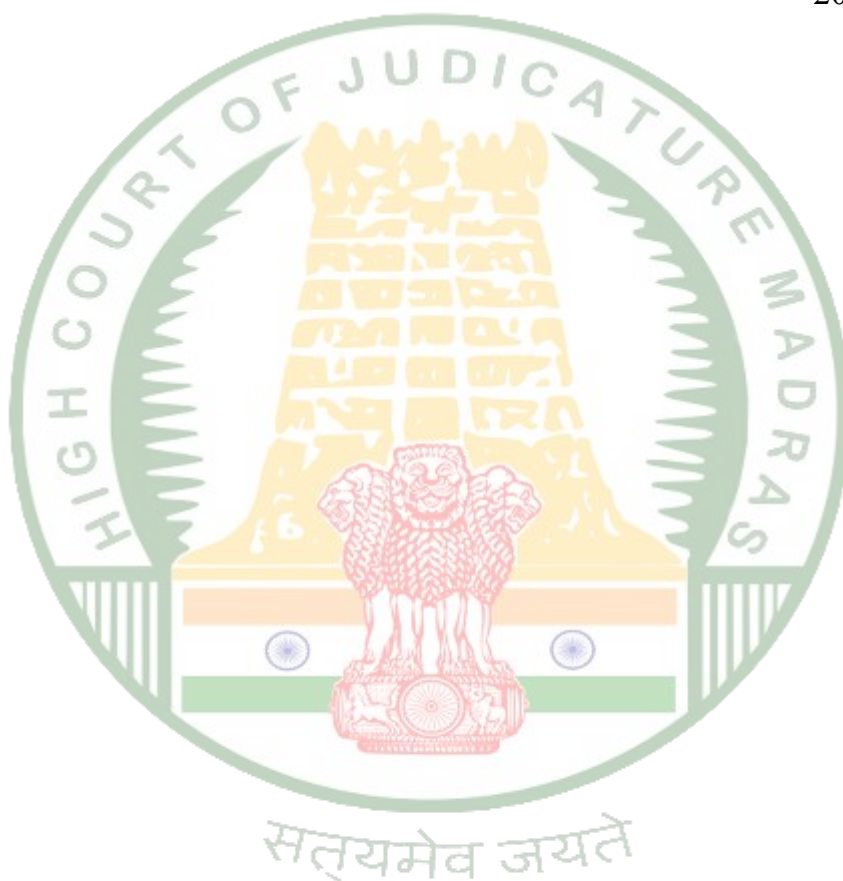
2. Heard the learned Special Government Pleader (AS) appearing for the appellant.
