This writ petition has filed to consider the writ petitioner for the post Junior Draughting Officer as per the notification of the second respondent dated 26.10.2015 in



filling up the vacancies without insisting on the upper age limit.

2. The learned counsel for the respondents referring to the G.O.No.117 of Minor Port Trust Department, dated 24.10.2018 submitted that pursuant to the directions of the High Court, the said notification was cancelled and the said post is being filled through Tamilnadu Public Service Commission by direct recruitment. The Special Government Pleader also produced a copy of the said Government Order.

3. The above submission of the learned Special Government Pleader has been placed on record. In view of the submission of the learned Special Government Pleader that the impugned notification has been cancelled by virtue of G.O.No.177, dated 24.10.2018 of the Highways and Minor Ports Department, nothing survives in this writ petition.

4. Accordingly, this writ petition is dismissed as infructuous. Consequently, connected miscellaneous petition is closed. No cost.
