2. Heard the submissions made on either side.

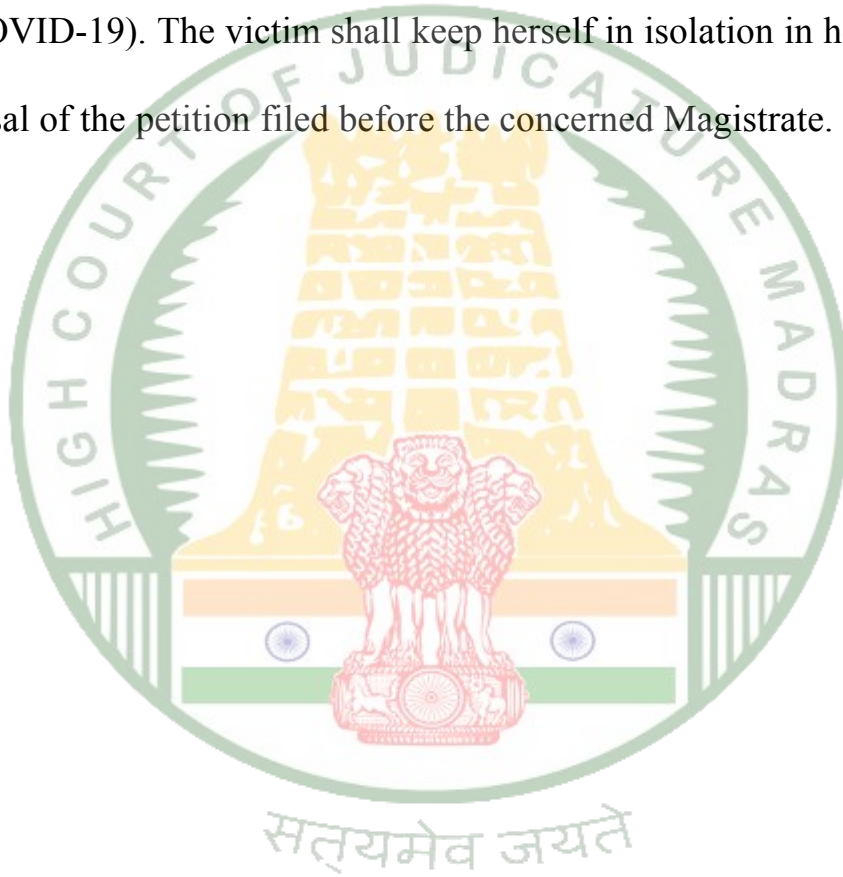

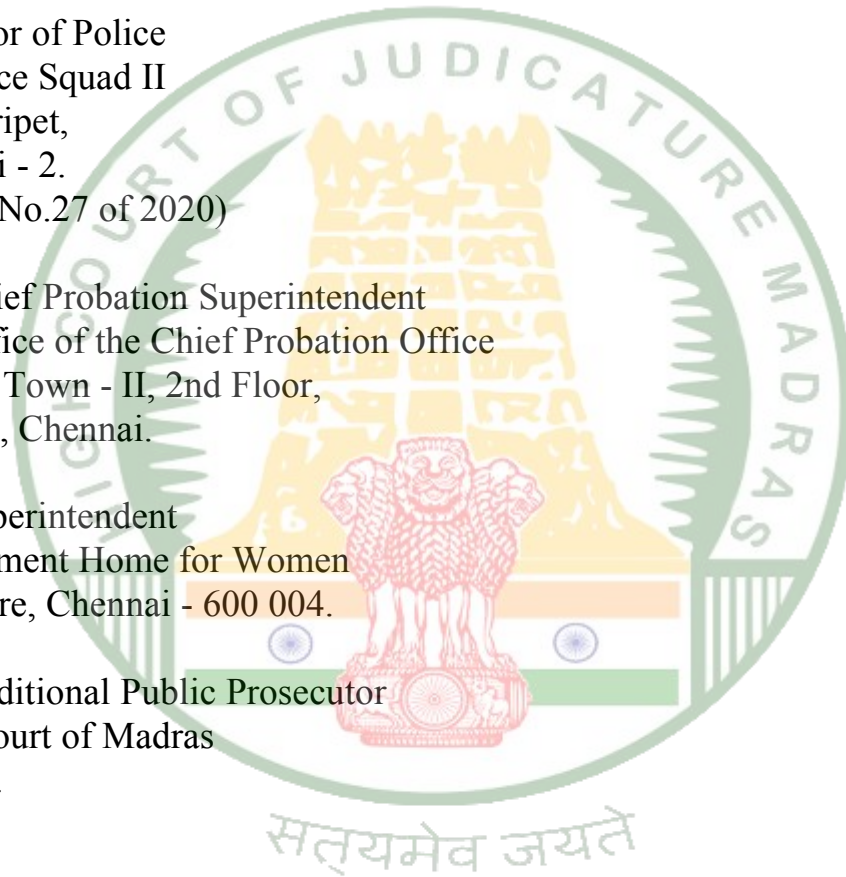

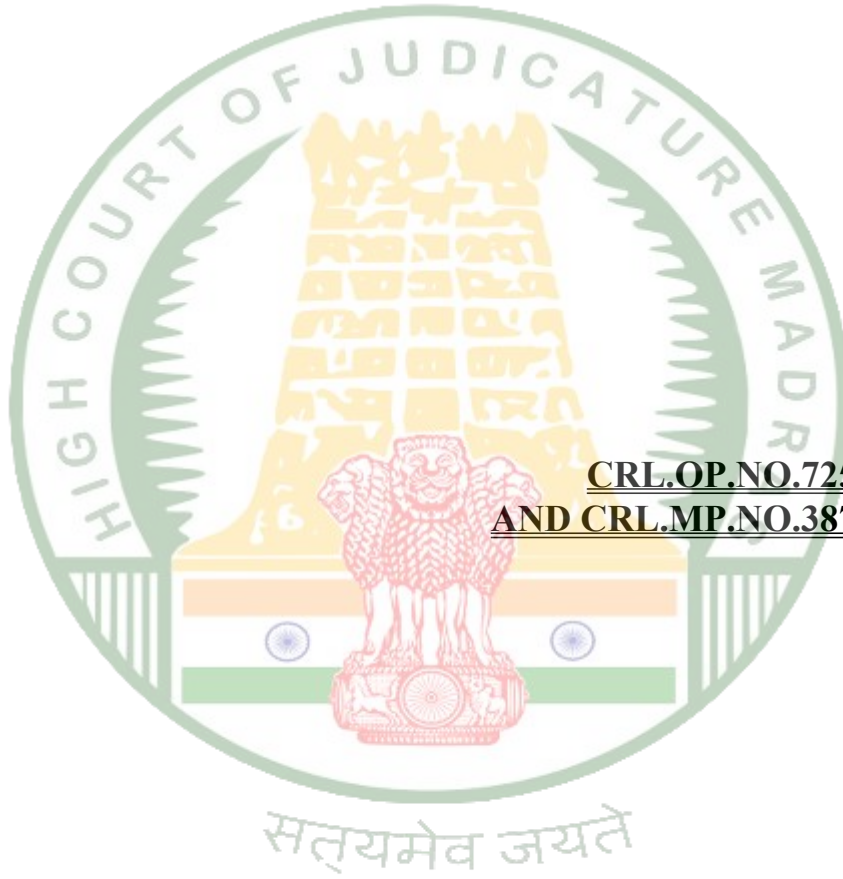
