Prayer :- Criminal Original Petition filed under Section 482 Cr.P.C. praying to modify the condition imposed on the petitioners by the learned Additional District Judge/ Presiding Officer, Special Court for EC Act cases, Coimbatore by an order dated 06.01.2020 made in CMP.No.13 of 2020 (i) The petitioners / accused No.1 to 4 are ordered to be released on bail on each of them executing a bond for Rs.25,000/- two solvency sureties each for a likesum to the satisfaction to this court and out of the two solvency sureties, one surety must be close blood relative of the petitioners/accused No.1 to 4 and the another one surety is from the resident of Tamil Nadu state (ii) The petitioner / accused No.1 to 4 shall report before the respondent / karungalpalayam police station daily twice in the morning at 10.00 am and in the evening at 5.00 pm without fail until further orders.
