b) The Petitioner shall report before the 2nd respondent police on the 1st and 15th of every Month at 10.30 a.m.

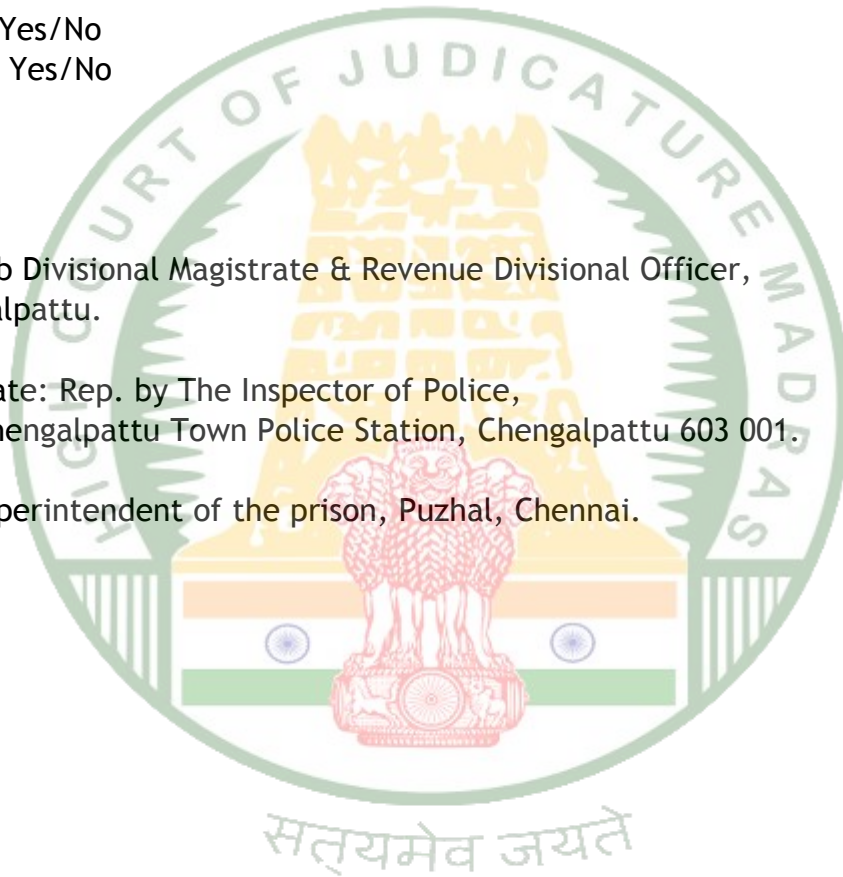
4. This Criminal Miscellaneous Petition is allowed accordingly.

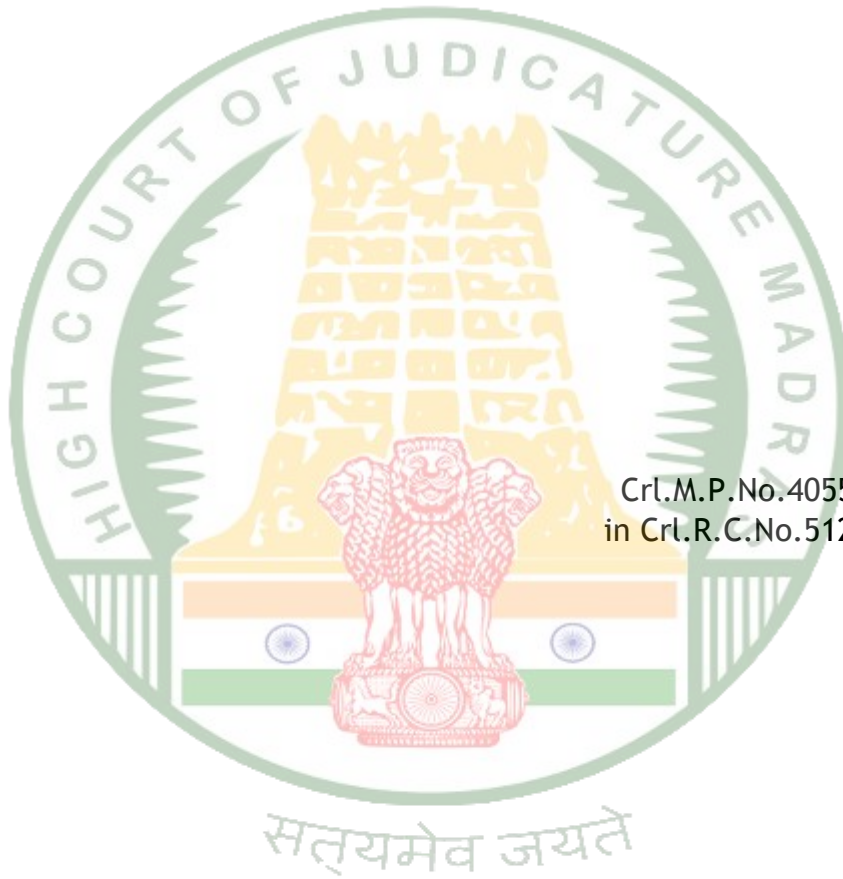
