Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus directing the respondents 2 to 5 herein to conduct enquiry considering the representation preferred by the petitioner dated 03.01.2020 and forbear the 7th

and 8th respondents herein from running saw mill in any manner in the land belong to 7th respondent herein bearing Survey No.142/2A1 measuring in extent of 35-1/2 cents at Munivazhai Village, Rishivandiyam, Kallakuruchi District, situate adjacent to the new site of the Petitioner School bearing Survey No.142/2A, 142/2B, 142/2C and 142/2D measuring in extent of 1.04-1/2 cents situate at Munivazhai Village, Rishivandiyam Sub-Registration District, Kallakuruchi District without obtaining license from the Competent Authority in the light of the judgment of this Hon'ble Court made in W.A.No.1706, 1707 & 1708 on the file of this Hon'ble Court dated 22.08.2012 and light of the G.O.No.256/2015 dated 22.12.2015 issued by the School Education Department.

The prayer made in this writ petition is to direct the respondents 2 to 5 to conduct enquiry, considering the representation dated 03.01.2020 preferred by the petitioner and forbear the respondents 7 and 8 from running saw mill in the land in Survey No.142/2A1 situated at Munivazhai Village, Rishivandiyam, Kallakuruchi District, adjacent to the land of the Petitioner School, without obtaining license from the Competent Authority.

2.When the matter was taken up for consideration, Mr.M.Elumalai, the learned Government Advocate, on instructions, submitted that the representation of the petitioner dated 03.01.2020 was already considered and appropriate orders were passed for closure of the saw mill on the ground that no permission was granted for running the same and the same was also informed to the petitioner.

3.Recording the submissions so made by the learned Government Advocate appearing for the official respondents, this writ petition stands closed. No costs. Consequently, the connected miscellaneous petition is also closed.
