Side) would submit that in pursuant to the order dated 28.05.2020 in Crl.O.P.No.7670 of 2020 passed by this Court, these cases have been transferred to the file of the Deputy Superintendent of Police, Organised Crime, Salem Unit. He would further submit that the petitioner in Crl.O.P.No.8689 of 2020 was arrested on 19.05.2020 and the petitioner in Crl.O.P.No.9730 of 2020 was arrested on 02.05.2020 and the investigation is in preliminary stage and these petitioners have also not impleaded the respondents who are conducting investigation now.
