in Cr.M.P.No.32/2020 dated 12.05.2020 detaining his husband as "Bootlegger", as contemplated under Section 2(b) of the Tamil Nadu Act 14 of 1982.

The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.2919 Home, Prohibition and Excise (XV) Department, dated 06.07.2020 and he has also produced a copy of the Government Order.
