Accordingly, this Writ Petition is disposed of, only with a direction to the respondents 3 & 4 to consider the representation of the petitioner dated 30.01.2020 for survey of the land etc., and pass orders on the same on merits and in accordance with law, after hearing all the parties concerned. Such exercise shall be done by the respondents 3 & 4 within a period of eight weeks from the date of receipt of a copy of this order. No costs.
