This writ petition has been filed seeking mandamus, directing the respondents to consider the application of the petitioner dated 01.04.2019 and for consequential direction to forthwith issue patta in the name of the petitioner for the lands measuring 1.05 acres in survey No.178/2 and land measuring 0.42 cents in survey No.182/1, totalling acre 1.47 cents at Agaram Then Village, Tambaram Taluk, Chengalpet District.
