3. In view of the above submission, the condition imposed as
against the petitioner in Crl.O.P.No.7657 of 2020 dated 29.05.2020
to execute sureties is extended. The petitioner shall surrender and
execute a bond for Rs.10,000/- with two sureties to the likesum
before the concerned Magistrate within two weeks from the date of
